We ask that you choose **three different** activities for the first, second and third choice. Failure to do so will result in the form being voided and a request sent to you for re-submission.

We have a limited allocation of funding available to support Pupil Premium students engage with our 2026 CEW. Please indicate when completing the online form for

activity preferences if you believe your child qualifies for funding support (up to 40% of the total trip cost).

Due to the limits on numbers for some activities we cannot guarantee your child will get their first choice, so we ask that each student is happy to engage with *any* of their three choices.

We will, of course, endeavor to give each student their first choice but this is not always possible. Please complete the online Microsoft Form by **Friday 21<sup>st</sup> November 2025** at the latest.

Once each student has been allocated an activity, we ask that you pay the non-refundable deposit by **Friday 9th January 2026**.

After this point, there will not be an option for students to change activities. If a student is *extremely* unhappy with their allocation, there will be a window of opportunity to appeal using the 'activity change request form'. This process will be explained to students during form time.

Throughout the spring and summer terms CEW activity leaders will meet with students to outline the week in more detail and discuss clothing, food, and transport arrangements.

We are delighted to be running Curriculum Enrichment Week 2026 and look forward to students taking full advantage of the exciting opportunities on offer.
